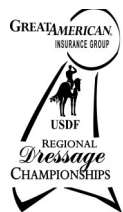

**Remember!** CDS CHAMPIONSHIP SHOW \$25 NOMINATION FEE: For the CDS Horse of the Year Championships there will be a \$25 Nomination Fee for each Horse/Rider combination due in advance of the show. These fees are used to help fund the Championship Show. The fees are payable directly to CDS and mailed to the Central Office prior to Championship Show. This fee does not apply to Futurity Classes.

**Remember!** DIVISION SPECIFICATONS: GAIG/USDF Region 7 & CDS Championship Classes will all be judged by two judges. All FEI Level Horse of the Year Classes will consist of one ride. Open Training through Fourth Level Horse of the Year Classes will consist of one ride. Junior and Adult Amateur Training through Fourth Level Horse of the Year Classes will consist of two rides on separate days. All Levels offer an optional WELCOME Class, Thursday.

**Remember!** FUTURITY SPECIFICATONS: The CDS 4, 5, and 6 year old Futurity are open divisions with prizes to first and ribbons through 8th. Prize money amount is determined by number of nominated horses and paid in each age group. **CAL-Bred** money is paid based on overall score regardless of age. (See page 12). Adult Amateurs entered in the Futurity will receive ribbons 1st—third in each age group. Amateurs will place as they are scored in the Open Futurity, winning all prizes associated with their placings.

## Futurity Division

All horses entered must have been born in 2017, 2018 or 2019. Horses who compete as 4 Year-Olds may nominate again the following year as 5 Year-Olds and again as 6 Year-Olds. Horses may have shown any level prior to the Futurity.

A nomination fee of \$100 must be paid prior to July 1, 2023. If paid after July 1, the fee will be \$150. Nomination fees are held in a special account and put into the purse the year the horse is nominated for the Futurity. There are no restrictions, other than age and no qualifying for the CDS Young Horse Futurity. **The CDS 4, 5, and 6 year old Futurity will each be an open division with prizes to first and ribbons through 8th. Prize money amount is determined by number of nominated horses and paid in each age group: 30%; 25%; 20%; 15%; 5%; 5%. CAL-Bred money is paid in the same percentage but based on overall score regardless of age. Adult Amateur Futurity Riders will receive separate ribbons 1st through 3rd in each age group. Amateurs will place as they are scored in the Open Futurity, winning all prizes associated with their placings. 4 & 5 year-olds will ride in a Material Class (counts 30%) and then Test 3 of Training (4-yr) Test 2 of First Level. (5-yr). Dressage tests count 70%. 6 year-olds will ride First Level Test 3 and Second Level Test 1 (each tests counts 50%).** No ribbons in Material or first class of 6-Yr-Old. Combined scored determine winners.

MATERIAL CLASSES will be split into smaller groups per USDF rules, of Mares/Fillies and Stallions/Geldings

At no time during the USDF/CDS CHAMPIONSHIP SHOW may any horse entered in that Championship be ridden by anyone other than the rider entered in the championship competition on the horse - one horse/one rider (exception: grooms riding on loose rein). This is in effect from the time the horse arrives at the showgrounds.

**Tests may not be called. Whips may not be carried. Riders must be prepared to ride in any class scheduled on any day.**

Horse/rider combinations that have competed in the Horse of the Year competition at Training through First Level who have placed Champion or Reserve will no longer be eligible for CDS awards at that level. Freestyles are exempt from this restriction.

CDS HOY classes are offered in three divisions for Training Level through Prix St. Georges, Open and Adult Amateur and JR/YR and two divisions for Intermediaire I through Grand Prix, Open and Adult Amateur. No cross-entries between divisions will be allowed. Adult Amateurs are defined as riders who are 22 years and over and hold a USEF Amateur Card.

A horse/rider combination must achieve the following scores for CDS qualifying: When two (2) or more judges score a single ride, the combination of judges counts as ONE judge and the average of their scores counts as ONE score. Horses must be at least 4 years old. Scores can be earned at any test of the level.

## USDF DRESSAGE SEAT MEDAL SEMI-FINALS

### Qualification Requirements

USDF Dressage Seat Medal Semi-Finals: Competitors can qualify by earning a qualifying score of 70% or higher in any open Dressage Seat Equitation class, between January 1 through the end of the qualifying period of the respective regional championship the rider plans to attend. Note: DSE classes such as USDF DSM Semi-Finals classes and USEF DSM Finals classes, which are restricted by criteria other than normal dressage rider categories of open, junior or junior/young rider, do not count for qualifying purposes.

Competitors may also participate in the USDF DSM Semi-Finals based on the fact that they are qualified for Regional Championships. Competitors who earn the necessary qualifying scores to participate in the Regional Championships at any level (excluding freestyles) are automatically qualified to participate in the USDF DSM Semi-Finals. Riders can elect to compete in any one of the 9 USDF DSM Semi-Finals, but may only compete in one semi-final competition per calendar year.

Protective headgear as described in the USEF Rule Book GR801 and DR 120.5 will be required for participation in these classes. For information on the Dressage Seat Medal Semi-Finals, please visit the USDF website at [www.usdf.org](http://www.usdf.org)

### Class Specifications

Two Semi-finals classes will be offered: one for riders 13 and under, and one for riders 14 through 18. The top two riders from each age division in each of the 2024 USDF Semi-finals will be invited to the 2025 USEF Dressage Seat Medal Finals the following year, in their respective age groups.

In all classes the rider's position, seat, and use and effect of the aids will be judged as outlined in DR 133. Competitors must wear protective headgear as described in GR801 is required in all semifinal and final classes. Competitors shall perform movements simultaneously, however, judges may ask for independent execution of certain movements. All instructions will be publicly announced. Riders must be judged at the medium walk, working trot (sitting and rising), and working canter both directions. They may also be asked to execute a free walk, transitions from one gait to the next in both directions, transition from the walk to halt and vice versa, and a change of direction. In small groups or independently they may be asked to show shallow loop serpentine in canter, maintaining leead, transitions, leg yield, changes of lead through trot, serpentine at the trot, show a shallow loop serpentine with counter canter, as well as trot or canter lengthening.

#### Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

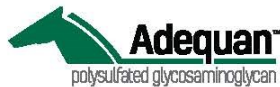

## USDF US Dressage Finals Eligibility

The US Dressage Finals is an Invitational competition using the USEF/USDF Regional Championship program to qualify. Qualifying takes place at each of the nine Great American/USDF Regional Dressage Championships, based on either 1) Ranking in a Regional Championship Class or 2) Wild Card Eligibility. Either must be achieved at a Regional Championship in a class and eligible division offered at the US Dressage Finals.

### I. Qualification Based on Ranking in a Regional Championship Class:

Champion and Reserve Champion horse/rider combinations for each level and eligible division from each of the nine Regional Championships will be automatically invited, provided the following three requirements are met: US Citizenship; Declaration of Intent completed by the deadline; and earning an eligible ranking in a Regional Championship class.

*Note: Beginning in 2023, Freestyle classes at Regional Championships will have two different classes per level, Open/Junior/Young Rider and Adult Amateur. The top two declared horse/rider combinations from the Open/Jr/YR Freestyle class and the top two declared Adult Amateur horse/rider combinations from the AA Freestyle class for each level from each of the nine Regional Championships will be automatically invited.*

*To be eligible for the Adult Amateur division in the Freestyles at the US Dressage Finals, competitors must check the AA box on the Regional Championship entry form and must provide proof of Adult Amateur status prior to competing in their Regional Championship classes.*

*New for 2024: The US Dressage Finals will offer a Prix St. Georges Jr/YR Final class as well as an Intermediate I Jr/YR Final class.*

- 1) United States Citizenship Requirement: To compete in any US Dressage Finals class, the rider must be a US citizen.
- 2) Declaration Requirement: The horse/rider combination must declare their intention to participate by completing the Declaration of Intent form by midnight on the day prior to the first day of their Regional Championship competition (including any open class day before the start of championship classes). **There is no fee to declare, but horse/rider combinations must declare at the level(s) and eligible division(s) they intend to compete in at the US Dressage Finals. Go to [www.usdressagefinals.com](http://www.usdressagefinals.com) to declare.**
- 3) Ranking in a Regional Championship Class: Eligibility to enter US Dressage Finals classes is based on a horse/rider combination's ranking in a Regional Championship class. Champions and Reserve Champions in eligible classes will be automatically invited, as long as they have declared by the deadline. *Note: In order to be named Champion and Reserve Champion in a Regional Championship class, a horse/rider combination must have achieved a score of 57% or higher.*

In the event that the Champion and/or Reserve Champion declines the invitation, or are ineligible to compete in the US Dressage Finals, the horse/rider combination that has the next highest ranking in the class will be eligible, providing they:

1. Are a US citizen.
2. Completed the Declaration of Intent for that particular level and division by the deadline.
3. Achieved the pre-requisite score of 57% or higher.

If that combination declines, the same process will be followed down through the fifth ranked declared horse/rider combination for that Finals level and division.

No notifications will be issued beyond the fifth ranked, of declared horse/rider combination except as may be eligible through the Wild Card invitations described below.

## II. Qualification Based on Wild Card Eligibility:

Horse/rider combinations who are not otherwise qualified to compete in the US Dressage Finals based on their Regional Championship ranking (see above) may be invited to participate in a Finals class by earning a Wild Card score achieved at one of the nine Regional Championships, provided the following two requirements are met: US Citizenship and earning an eligible Wild Card score in a Regional Championship class.

- 1) United States Citizenship Requirement: To compete in any US Dressage Finals class, the rider must be a US citizen.
- 2) Eligible Wild Card Score: Eligibility to enter US Dressage Finals classes is based on a Wild Card score earned in a Regional Championship class. For all levels and divisions from Training through Grand Prix, a horse/rider combination that competes in a Regional Championship class and achieves a score at or above the score listed below for that level and division may compete in the same level and division at the US Dressage Finals.

*Note: Horse/rider combinations are not required to have filed a "Declaration of Intent" in order to receive a Wild Card invitation.*

## III. Invitations:

Invitations and notifications will be emailed to eligible/qualified horse/rider combinations immediately after each Regional Championship. There will be three categories of emails:

- 1) Invitation emails will be sent to the top two of the top five declared horse/rider combinations.
- 2) Invitation emails will be sent to combinations eligible for a Wild Card.
- 3) Notification emails will be sent to the third to fifth declared horse/rider combinations, notifying them that they are on the reserve/alternate list and reminding them to check the website for any status changes that would make them eligible for an invitation.

In the event that an invited horse/rider combination scratches, invitations may be issued up to the start of the competition.

*Note: Competitors do not need to receive an actual invitation to nominate themselves for the US Dressage Finals. The entry system will have their eligibility status and they can nominate prior to receiving an email invitation.*

## IV. Nomination Requirement:

Nomination, including payment of the nomination fee, is required for participation in US Dressage Finals classes, whether qualifying through ranking in a Regional Championship class or by Wild Card Eligibility. The nomination deadline is midnight, 96 hours after the last championship day in the regional championship show in which the horse/rider combination competed. Each US Dressage Finals horse/rider combination is required to complete the nomination (preliminary entry) process including the

horse/rider combinations on the reserve/alternate list. The Nomination fee paid will be applied to the total amount due at Closing Date.

V. Entry Requirements

Completed entries for the US Dressage Finals *must be received* by the closing date, Saturday, October 19th midnight Eastern Time. Priority for all stabling requests (including stabling in Alltech Barns and for double stalls) will be based on the date of receipt of the COMPLETE online entry. Each online entry must include the following: full payment, fully signed 2024 US Dressage Finals entry form and signed USEF Waiver, current negative Coggins test and current Flu/Rhino Vaccine Record. All documents must be uploaded when you receive your online entry confirmation from [Horseshowoffice.com](http://Horseshowoffice.com), that is emailed immediately to you after you enter online. The last factor in determining stabling priority will be the allotted number of Alltech stalls available per region.

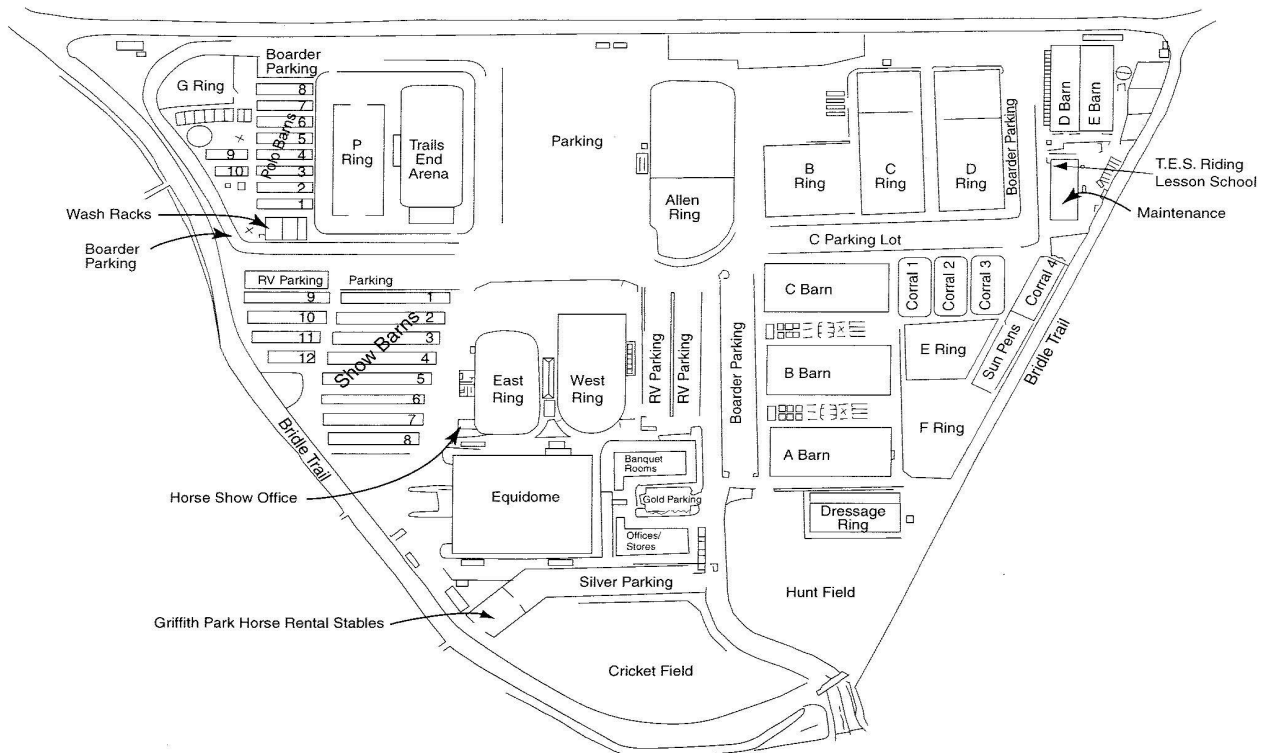

# RULES & GENERAL INFORMATION

1. **The Great American/USDF Region 7 and CDS Championships** is covered by the rules and specifications of the current US Equestrian Rule Book and will be conducted and judged in accordance therewith.

2. **Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides.** A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

3. **FEDERATION ENTRY AGREEMENT:** By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of the United States Equestrian Federation, Inc. (the "Federation") and the local rules of Dressage Association of Southern California, United States Dressage Federation, and California Dressage Society. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable casts, broadcasts, internet, film, new media or other likenesses of me and my horse taken during the course of the competition for the promotion, coverage or benefit of the competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4. If not currently a USEF Active Competing member or Subscriber, I acknowledge that I will be enrolled for no cost as a USEF Fan and my USEF Fan Account will continue to annually automatically renew in USEF's sole discretion. Additionally, I acknowledge that the benefits of a USEF Fan are subject to change without notice. USEF may in its sole discretion, at any time, terminate my USEF Fan status.

4. **Amateurs, Juniors & Young Riders:** Amateurs are defined by the rules and specifications of the current USEF Rule Book. *All riders entering the Amateur classes must possess or have applied for an USEF Amateur Card prior to riding in the class.* All riders in Amateur Divisions must present a USEF Amateur Card when picking up their number or they will not be allowed to show in the Amateur Division. Cards may be applied for at the show office. Jr/ YR rider classes are offered to anyone 21 and under (may compete until the end of the calendar year in which they turn 21) Young Riders are eligible for FEI YR classes from 16-21 years of age; Junior FEI classes from 14-16.

5. **CONDITIONS OF ENTRY:** Every horse entered for competition will be under the control of the Horse Show Management, but Management will, in no case, be responsible for any loss or damage that may occur, and it shall be a condition of entry that each exhibitor shall hold the Horse Show and its Directors harmless for any loss or accident to his horse, horses or equipment which may occur from sickness, fire or otherwise.

## 6. ENTRY PROCEDURES: PLEASE READ CAREFULLY!!

**A. We encourage entries be filled out <https://entry.foxfillage.com>** You may also download the entry form, scan and email to the show secretary [mmmdressage@gmail.com](mailto:mmmdressage@gmail.com). Please submit a completed and signed entry form. Include copies of your membership/horse registration cards, proof of Freestyle score eligibility (if entered in a freestyle) along with all fees. Entries without membership cards will be charged a \$25 internet search fee. Incomplete entries may be charged a Late Fee. **SEND PAYMENT OR CC INFORMATION WITH ENTRY. ENTRIES SENT WITHOUT CREDIT CARD INFORMATION WILL NOT BE ACCEPTED.**

**B. Entry Acceptance:** Entries will be accepted on a first come-first served basis through closing date or until show is full. Entries received by August 18 will have a \$95 Office Fee. Entries received between August 19 and the closing date, September 2 will incur a \$135 Office Fee. **After closing date, late class entries will be accepted only if schedule permits, with a \$100 Office Fee & \$100 Late Fee and Late Stall Fee.** If classes are full, competitors with entries received after Closing Date, will be notified and, if desired, put on a waiting list. Those on a waiting list, not getting into the show, will have all fees refunded. NO PHONE entries will be accepted. All entries must be made **on official entry blanks and filled out completely as to classes, exhibitors names, addresses, phone numbers, association numbers, and signatures.** Parents/guardians must sign the official entry blank of a minor before a number will be released. **You may enter prior to having all qualified scores. If you are not qualified, fees for those classes and related charges will be refunded.** Competitors who are properly qualified, whose complete entries are received by closing date, and who have complied with all championship rules will not be denied entry into classes for which they have qualified.

## 7. SCRATCHES & REFUNDS:

**A. YOU MUST NOTIFY THE SHOW SECRETARY BY EMAIL OF YOUR DESIRE TO SCRATCH, [mmmdressage@gmail.com](mailto:mmmdressage@gmail.com)** INCLUDE YOUR NAME AND NAME OF HORSE All fees, less Office Fee paid at time of entry, will be returned if horse is scratched before Closing Date.

**B. AFTER THE CLOSING DATE THERE ARE NO REFUNDS OF ANY FEES, INCLUDING, OFFICE, CLASS AND STALL/TACK ROOM FEES FOR ANY REASON, INCLUDING MEDICAL AND VETERINARY.** (If you scratch and you wish to keep the tack or grooming stall for your other horses or your barn, it will be charged on your entry. YOU MUST INCLUDE THIS INFORMATION WHEN YOU SEND

THE SECRETARY YOUR SCRATCH. **Stalls are not refundable or transferable** A scratched horse's stall will not be kept if Show Secretary was not notified at the time of the scratch. Please also note, after scratches are received, stalls may be reassigned, moving a showing exhibitor to a different location that was previously unavailable.)

**C. NO REFUNDS WILL BE GIVEN IN THE EVENT A CLASS, CLASSES, THE EVENT OR ANY PART OF THE EVENT IS CANCELED DUE TO WEATHER, OTHER ACTS OF GOD, OR CATASTROPHE:** Including but not limited to, rain, wind, fire, heat, air quality, acts of terrorism, illness, or facility failure..

**8. Schedule:** Riders must be prepared for any GAIG/USDF Championship or CDS Championship to be scheduled any day Thursday-Sunday with USDF rules. If you wish to restrict the maximum number of rides per day, you must indicate on your entry and which classes you would prefer to drop.

**9. Competition Arenas:** Four or Five standard 20mx60m arenas of composition and sand footing will be used. Horses are not permitted in or around competition arenas on show days at other than scheduled ride times. *Violation of the above will be cause for elimination from the show.* **Warm-up areas** will be available for each competition ring and also consist of composition and sand footing. Additional warm-up and lunging will be sand footing.

**10. Ride Times:** Preliminary ride times will be emailed to all exhibitors and posted on the CDS website prior to the show. OFFICIAL TIMES WILL BE POSTED BY NOON THE DAY BEFORE THE COMPETITION (DR126.1.b.3). They will also be available on line. SCHEDULED TIMES MAY NOT BE CHANGED EXCEPT IN COMPLIANCE WITH RULE GR830.5. IT IS THE RESPONSIBILITY OF EACH COMPETITOR TO CHECK THE OFFICIAL RIDE TIMES There may be considerable time between rides, if you enter different levels. Information will be sent in with ride times, and in rider packets, that will contain information on any awards schedules, stabling, other pertinent information.

**11. Warm-Up Arenas:** Only horses entered in the show and actually warming up for a class will be allowed in the warm-up areas. No one on foot will be allowed in the arm-up areas at any time. Lunging is to be done only in specified areas.

**12. TESTS:** The Current FEL, USDF and USEF Tests will be used.

**13. Musical Freestyles:** It is the responsibility of the exhibitor to get their music emailed to the announcer Please include rider/horse and class #. Send directly to the announcer, **Noah Ratner at noah.rattner@devonwoodec.com** and a copy to the show secretary, **Meaghan Mal-lory at mmdmessage@gmail.com**. Freestyle riders may have a representative at the announcer's stand to tell the announcer when to start and stop the music. **A back-up CD, MP3 or WAV file is required at the show. No cell phones or zip drives.**

**14. Horse Numbers** must be worn at all times when horses are out of their stalls, mounted or unmounted, while the show is in progress.

**15. Stabling:** Permanent MD and wood Barns (12'x 12') with dutch doors. Only horses entered in the show will be assigned stalls. Horses may arrive any time after 2:00 P.M. on Tuesday and must leave by 9:00am on Monday. If you need to arrive earlier or stay longer you must make special arrangements with the management—Additional fees may be required. The **Early-Bird** (prior to 8/19) cost per stall is **\$225 (PACKAGE A)** whether used for horse or tack. **Stalls ordered between 8/19 and closing date are \$250 (PACKAGE B) Stalls requested after the closing date (September 2) are \$295 (PACKAGE C)** Priority Stabling is given to Sponsors first, on a first come first serve basis with consideration of stall group when mapping requests. We try to accommodate special requests; however, we are not always able to give first preference. THERE IS NO REFUND FOR STALLS.

**16. Feed and Bedding** *No straw is allowed for bedding.* Feed and bedding orders are made directly through LAEC . Direct line :818.971.2277; Fax 818.973.1048; Email-**feed@la-equestriancenter.com**. Initial orders must be placed by noon on Monday, September 23 to guarantee they will be at your stall when you arrive. Other orders must be made by noon. There are no deliveries on Sunday.

**17. Grounds Fees of \$75 per horse per day** will be charged for horses entered in the show but not stabled on the grounds. You are only allowed to haul in if ALL of your classes are on one day. According to USEF rules for Championship shows, if you are entered in more than 1 championship class and they are not scheduled on the same day, you MUST stable on the show grounds. **NOTE: All horses competing in Regional Championship classes must be stabled on the grounds for the duration of their participation in the event, from the time of arrival until the horse has completed in all classes. IF a horse has been found to have left the grounds and returned, it would be eliminated from all Championship Classes. (USEF DR 127.8)**

**18. RV Parking:** May be ordered on your entry at \$75 per day.

**19. Food:** Will be available on the show grounds.

**20. Horse/Washing:** Do not wash horses in the barn area. Please use the wash racks. We recommend that you have a garden hose available.

**20. Stall Cleaning:** Please deposit all manure at the far end of the barn aisles.

### 21. Awards/Prize Money:

a) "Prize money for the Great American/USDF Championships will be paid directly by the USDF office to the recorded horse owner within thirty (30) days of the last day of each championship. Champions and Reserves who obtain a score of 57% or better will receive prize money. Champions in each region and division will receive \$440 in prize money. Reserve Champion will receive \$292 in prize money. Awards to Champion & Reserve and ribbons to 8th.

b) WELCOME classes, will have awards to 1st place. Ribbons through 8th place.

c) CDS HOY Open and Adult Amateur Championship classes with prize money paid through 5th place (30%-25%-20%-15%-10%); Championship Jacket to 1st, ribbons to 10th. CDS Youth Championship classes have no money, championship Jacket to first and ribbons to 10th. First—Fourth Level CDS Freestyle Classes have prizes to first and ribbons to 8th. Additional information on page 13. Prize money will be sent within 30 days of conclusion of show. Futurity prize information see page 12

## **RULES & GENERAL INFORMATION CONTINUED:**

**22. Dogs:** Dogs or pets must be on a leash AT ALL TIMES. If your pet is a nuisance to others or cannot be controlled, you may be asked to contain your pet or leave the show grounds.

**23. Awards Ceremonies:** Riders placing in **Great American/USDF Regional Championship** classes must be present, mounted and in full riding attire for awards ceremonies (eight places for all Championship classes). Attendance to award ceremonies is not mandatory, but riders should let show management know if they are not attending. In the case of inclement weather, unmounted ceremonies may be held. Riders placing First or Second in CDS Championship Classes and Futurities must be present, mounted and in full riding attire for awards.

**24. USEF COMPLAINT PROCEDURES:** See the **USEF By-Laws for complete complaint procedures:** The Hearing Committee has jurisdiction to hear NGB Compliance Complaints as defined above that are properly filed against the Federation by any Life Member, Senior Active Member, or Junior Active Member, so long as the Petitioner agrees to be subject to the applicable Complaint Procedures and to be bound by any decision rendered pursuant to those Complaint Procedures. Section 2. Filing Requirements. a. Manner of Filing. An NGB Compliance Complaint must be filed with the FRD at [disputes@usef.org](mailto:disputes@usef.org) with a copy to the Federation President at [president@usef.org](mailto:president@usef.org) and the General Counsel at [generalcounsel@usef.org](mailto:generalcounsel@usef.org), using the form provided by the Federation on the Federation's website.

**25. MOTORIZED VEHICLES:** Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this Rule VV

**26. Medical Waste:** In accordance with the rules of USEF Bio-Hazardous Medical Waste (SHARPS) containers are provided in the stable area. All exhibitors, their grooms, and their agents are responsible for the proper disposal of this waste.

**27. HELMETS:** From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competition riders on non-competition, mounted participation in exhibition classes and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR108. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. Protective headgear is defined as a riding helmet which meets or exceeds ASTM (American Society for Testing and Materials) SEI (Safety Equipment Institute) standards for equestrian use and carries the SEI tag. The harness must be secured and properly fitted.

### **IMPORTANT NOTE:**

**USEF Championship rules apply from the time of arrival on the grounds. GAIC/USDF & CDS Championship classes no readers & no whips. This means horses must remain stabled on the grounds once they arrive.**

### **Reminder:**

All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. **Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

**Exceptions:**

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

**Memberships Defined**

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21<sup>st</sup> birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan<sup>®</sup>/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan<sup>®</sup>/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$115) is eligible for Adequan<sup>®</sup>/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

**How to Join USDF**

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.



## 2025 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at [www.usdf.org](http://www.usdf.org). Please refer to the 2025 USDF Member Guide for the comprehensive list of rules and requirements for this program.

### Membership/Registration Requirements for Qualifying and Championships

*All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.*

Rider:

- Must have a USDF Participating\* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).  
A horse is not required to have breed registry papers.
- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

\* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider.

The minimum percentages are as follows:

	OPEN	AA	JR/YR
Training Level (Test 3)	68%	63%	63%
First Level (Test 3)	66%	62%	62%
